The Committee was established in concern with that if grievances received by the Principal it will be forwarded to the concerned Committee members who look in to the problems depending upon the seriousness of the issue.






The Committee has been continuously striving to take the best efforts possible to create a harmonious and conducive atmosphere to everyone in question.


### THE FOLLOWING RESOLUTIONS WERE MADE :
