Dr.P.P.Waghmare also expresses his thoughts about the Rights of Minority and various aspects in the Constitution of India.

Article 30(1): "All minorities, whether based on religion or language, shall have the right to establish and administer educational institutions of their choice.

"Article 30(2): It ensures that the state cannot discriminate against any educational institution based solely on its minority status.

Fundamental Rights

Article 15: Prohibits discrimination on grounds of religion, race, caste, sex, or place of birth.

Article 15(1): "The State shall not discriminate against any citizen on grounds only of religion, race, caste, sex, or place of birth."

Article 15(2): Prohibits discrimination in access to public places, including shops ,hotels, and public entertainment places.

Article 25-28: These articles ensure freedom of religion and the right to religious practices.

Article 25: Guarantees freedom of conscience and the right to profess, practice, and propagate religion.

Article 26: Provides freedom to manage religious affairs, including the establishment and maintenance of institutions for religious and charitable purposes.

Article 27: Ensures that no person is compelled to pay taxes for the promotion of any religion.

Article 28: Prohibits religious instruction in educational institutions wholly maintained out of State funds, though it allows religious instruction in institutions run by religious or linguistic minorities.

Article 29(1): "Any section of the citizens residing in the territory of India or any part thereof having a distinct language, script or culture of its own shall have the right to conserve the same."

Article 30: As mentioned earlier, this article is particularly significant for minorities in providing the right to establish and manage their educational institutions.
